NARRATIVE: On April 10, 2026, at approximately 6:30 p.m., a 2026 Polaris Ranger was traveling westbound in the 12200 block of 71st Street SE, approximately 2.5 miles southwest of Elliott. The driver was operating on a minimum maintenance road that was muddy and snow-covered. The driver lost control, ran off the roadway, overcorrected back onto the roadway, and overturned.

The side-by-side was occupied by a male driver, two adult female passengers, and two juvenile passengers. All occupants were transported to CHI Lisbon Health for injuries sustained in the crash. The driver was later airlifted to Fargo for treatment of serious injuries.

Juvenile names will not be released. The crash remains under investigation by the North Dakota State Patrol.
