Driver No. 3: Female, 53, minor injuries

Restraints: Seat belt in use

NARRATIVE: On May 21, 2026, at approximately 11:45 p.m., a three-vehicle injury crash occurred at the intersection of 42nd Street South and 52nd Avenue South in Fargo. A Chevrolet Impala was traveling southbound on 42nd Street South at approximately 45 mph and ran a red light. A Chevrolet Equinox was traveling westbound and had entered the intersection just prior to the Impala. The Impala struck the Equinox on the driver's side. The Equinox left the roadway to the south and overturned. After the initial impact, the Impala began rotating clockwise and was then rear-ended by a Jeep Cherokee.

Occupants from all three vehicles were transported to Essentia Health. The occupants of the Chevrolet Impala and Chevrolet Equinox suffered serious injuries as a result of the crash. The driver of the Jeep Grand Cherokee suffered minor injuries.

The crash remains under investigation by the North Dakota State Patrol.
