NARRATIVE: On Thursday, July 30, 2026, at approximately 3:21 p.m., a 2007 Harley Davidson was traveling west on Main Avenue. The driver failed to stop for a red light at the intersection of University Drive and Main Avenue and attempted to continue through the intersection. A 2023 Subaru Ascent was traveling south on University Drive and crossing the intersection. The Harley Davidson collided with the back of the Subaru, and the rider was thrown from the motorcycle. A Ford F150 then struck the rider. The motorcycle struck a 2006 Ford Fusion which was behind the Ford F150. The motorcycle rider was taken to Sanford Medical Center where he died of injuries. None of the other motorists were injured.

The crash remains under investigation by the North Dakota State Patrol.
