**NARRATIVE:** On February 13, 2026, at 6:40 p.m., a Nissan Rogue was traveling eastbound on 49th Avenue South and started to cross 45th Street at an intersection marked with a stop sign, while a Ford F-150 was traveling southbound on 45th Street.

The Nissan Rogue was struck on the driver's side by the front right of the Ford F-150 in the intersection. Both vehicles crossed the northbound lanes and came to rest in the southeast corner of the intersection.

The occupants of the Nissan Rogue were transported to Sanford Medical Center. The passenger of the F-150 was transported to Essentia Health.

The names of juveniles will not be released, N.D.C.C. § 27-20.2-21. The crash remains under investigation by the North Dakota Highway Patrol.
